I found this in a Handwoven magazine years ago. When I gift someone a towel, I would enclose a copy. Since towels are a thing this year, I thought I would share.

The Life of a Handwoven Towel

The luckiest handwoven towels belong to weavers. These towels are caressed daily and they likewise caress and care for their owners and belongings. They are exercised daily and groomed often. They never want for light, air, or companionship.

As they age, they are more beloved for their experience. They are never discarded, as each thread carries with it a life-time of memories.

Pity the towel given as a gift to the non-weaver. It spends most of its lifetime waiting for a special occasion—all dressed up with no place to go. It lives in a drawer surrounded only by other towels, each one calling “Pick me! Pick me!” when the drawer is opened. A few of these towels may eventually be selected by the executor of an estate as items worthy of appraisal. Some may even end up in museums. They will never be bathed, as the fibers might deteriorate. They will never be touched, stroked, or loved, as this might impart damaging oils. They will be handled with gloves, protected from bright light, and admired by only a few, who will be overheard to say, “Oh, I’ve got one like that at home! I’ve never used it; it was my mother’s.”
